The Planning Commission also hereby resolves to authorize its chairperson to cancel one or more such regular meetings and give reasonable notice of any such cancellation to the members of the Planning Commission and the general public, upon determining there is no known business to come before the Planning Commission at the meeting; provided that the Planning Commission shall comply with the statutory requirement to hold not less than four regular meetings each year, which is herein interpreted to apply on a calendar year basis.
